Minutes : This item was approved by the Council and following are some of the highlights of this R-20 Academic Regulations:

For MCA Program :

- Duration of MCA Program has been changed from Three years to Two years as per AICTE guide lines with effect from 2020-21.
- Vision, Mission, POs, PEOs of MCA Program have been redefined according to two years program
- Number of Credits for two year program :96 (Credits range given by AICTE:96-102)
- Summer internship is Mandatory after II semester with 2 credits
- Increase of CIE from 30% to 40%
- Increase of Condonation Fee from Rs.1000/-to Rs.2000/-

For MBA (SMS) Program :

- Personality Development and Career Guidance is introduced in II Semester with 2 credits
- Project work hours increased from 4 to 8 under P (Practical).
- Business Analytics elective subject 'R-Programming' is replaced by 'Python Programming' in III Semester. IV semester HR elective subjects: Leadership and Team Management' & International Human Resource Management are replaced by Industrial Relations and Labour Laws' and 'Strategic Human Resource Management'
- Credits for the Comprehensive Viva Voce I & II increased from 1 to 2
- Credits and Hours for Core subjects in III & IV Semester i.e. Strategic Management & Entrepreneurship Development increased from 3 to 4
- Increase of overall credits from 107 to 112
- Increase of Condonation Fee from Rs.1000/-to Rs.2000/- as per OU.

- Focus on the Soft Skills to be strengthened in all the Departments



Request from IQAC Director

The required pass marks are 40% of the sum of CIE & SEE Marks. Even in repeated attempts, very few of the Students are unable get the pass marks due to very less marks in CIE. The CIE marks can't be improved further and few of such Students are leaving the Institute. As we are following CBCS, the detained Students may be permitted to Re-register one or two such Course(s) enable them to improve CIE marks also.

Principal opined that the detained Students are not permitted for enrolment; hence, it is not appropriate to permit such Students. However, the Remedial Classes will be arranged to such Students to complete the Course/Subject.
