The following vacancies are details of vacancies to be filled during Spot Admissions to be conducted on 29.12.2020 (Tuesday) at 10.00 A.M in CBIT college campus.

#### **VENUE: CBIT Campus**

Interested qualified candidates who have not taken admission in any other Institute can apply in person on **29.12.2020 between 10 AM to 12 Noon** in CBIT Campus.

All the applied candidates need to Attend Spot Admissions with all the original certificates, Tuition Fee and Miscellaneous Fee of Rs.1,34,000/- + 8500/- for all branches in the form of DD in favor of "CBIT FEE COLLECTION AND OTHER RECEIPTS" payable at Hyderabad.

### Eligibility Criteria:

- 1. Candidates shall not be allowed for spot admission without verifying original certificates.
- 2. The vacancies shall be first filled with the internal sliding candidates and the final resultant vacancies shall be filled under spot admissions.
- 3. The vacancies are to be filled first with those qualified in TSEAMCET(B)-2020 and possessing 45 % (44.5% and above can be taken as 45%) marks in group subjects in respect of other than SC/ST/BCs and 40% (39.5% and above can be taken as 40%) marks in group subjects in respect of BC/SC/STs are eligible for spot admission.
- 4. If the vacancies are still left, candidates without TSEAMCET Rank and passed intermediate or its equivalent examination with the percentage of marks indicated above shall be considered.
- 5. While affecting the internal sliding please note that, a category seat vacated by a candidate should be first given to that category candidate and if the candidate is not available the same should be offered to the next reservation

- category as mentioned in the annexure before diverting the seat to open competition.
- 6. Similarly, the dropout vacancies (Reported but discontinued) shall be given only for that category.
- 7. Likewise, the not reported cases and cancelled cases should be given only for that category.
- 8. If a particular candidates is not available, they should be converted to another categories as per the Annexure enclosed i.e., finally after exhausting all category candidates the vacancies should be diverted to open category.
- 9. Candidate belonging to other state and completely studied there (Other State) and whose parents belong to other state and residing there only is not eligible for admission. He/She cannot be considered even as Non-Local (NL) candidate to Telangana State for admission and ratification will not be given for such cases if they admit the candidate by violating the guidelines issued.
- 10. Further the candidates admitted during spot admissions are to be informed that institutional their spot admissions are subject to ratification by the Convenor, TSEAMCET(B)-2020 Admissions. In case if spot admission given to a particular candidate is not ratified by the Convenor, He/She has to quit college immediately. This to be made clear to every candidate on the day of conducting the spot admissions in the college.
- 11. Candidates possessing intermediate or its equivalent certificates other than those issued by the Board of Intermediate Education, Telangana/A.P shall be asked to get the equivalency certificate from Board of Intermediate Education, Telangana before granting admission.
