

This has reference to the proposal submitted by Chaitanya Bharathi Institute of Technology, Kokapet (Vill.), Gandipet, Rangareddy Dist. Hyderabad-500 075, Telangana affiliated to Osmania University for extension of autonomous status under the UGC Scheme for Autonomous Colleges.

The Standing Committee constituted by University Grants Commission in its meeting held on 25.06.2019 decided to extend the autonomous status to Chaitanya Bharathi Institute of Technology, Kokapet (Vill.), Gandipet, Rangareddy Dist.
