The item no 1. Was discussed at length and it was resolved to follow the following suggestions of BOS members regarding the course structure and syllabus for M.B.A 1st year1stsemester for the academic year 2013-14.

1. The "Marketing Management" paper which was included in the 2nd semester under proposed course structure was shifted to the 1st semester in place of Business law.

The UNIT -IV has been removed in Marketing Management and in its place the Branding concept is included.

- 2. The "Managerial Communication" paper which was in the 3rd semester presently in OU syllabus was renamed as "Business Communication" and shifted to 1st semester and some more new concepts were added to the existing syllabus.
- 3. In the subject "Information Technology Applications for Business" (Theory), the number of periods per week are fixed as 4 periods instead of 5 and ITAB (Lab) reduced from 3 to 2 periods.

In the subject of ITAB some changes are made in UNIT- III. In addition to the advanced concepts in information system, the conceptual framework of ERP (Enterprise Resource Planning) has been included. The supply chain management, customer relationship management and procurement management topics were removed from the present syllabus of OU.

In ITAB (Lab), MS word also included.

- 4. "Business Law" which is in 1st semester was shifted to 2nd semester in place of "Business Process Reengineering" (BPR).
- 5. In the subject "Managerial Economics" the UNIT -V is replaced by the concepts of Indian economy and Business environment.

- 6. Referencing style has been modified and Harvard referencing style was followed. Suggested readings were divided into Essential Readings and Suggested Readings.
- 7. For each course, the objective of the course is mentioned at the beginning of the syllabus to understand the importance of course by the student
- 8. In "Financial Accounting and Analysis" subject, the concept in the 1st UNIT was
- 9. For each course, the credits has been given based on the weightage of the course.
- 10. In the subject "Management and Organization Behavior", the UNIT wise structure has
