### Item No.1 : Approval of mandatory course - Indian Constitution and Fundamental Principles - for BE III & IV Semesters (All branches)

**Minutes** : The members have suggested that the course objectives be rewritten and need not be identical to the course outcomes. The course work should be done in the form of field trips, hands on experience, attending meetings, visiting the court of Law etc. This would make the course interesting and challenging. It was also suggested that students may be given projects and case studies and marks allotted for them along with the semester end written examination. Suggested reading (reference books) may be 3 or 4.

### Item No. 2 : Approval of -Audit Course I -English for Research Paper Writing - M.Tech I/II Semester(All branches)

**Minutes** : All the members of the Board of Studies suggested that the AICTE syllabus was ambiguous and not in order. They suggested that the first unit should be on the basics of academic writing - word order, paragraph writing, coherence and cohesive devices. The other units should constitute - conceptualising research, narrowing it down, framing a title, writing an abstract, review of literature, writing first draft, redrafting etc. The students should also know how and where to get their papers published. It was suggested that GNITS audit courses could be taken into consideration while framing the units.

### Item No. 3 : Approval of Audit Course II - Constitution of India - M.Tech I/II Semester (All branches)

**Minutes** : All the members of the Board of Studies have unanimously approved of the course, Constitution of India. They advised that the syllabus should be error free in terms of punctuation.

### Item No. 4 : Approval of Audit Course III - Stress Management by Yoga - M.Tech I/II Semester (All branches)

**Minutes** : All the members of the Board of Studies have advised that the course objectives be written more clearly. The units were approved of but details were requested in every unit. It was suggested that counsellors, yoga trainers should also be approached to deal with a few aspects of the syllabus.

### Item No. 5 : Approval of Audit course IV -Personality Development through Life Enlightenment Skills - M.Tech I/II Semester (All branches)

**Minutes** : All the members of the Board of Studies have suggested there should be uniformly 3 course objectives. They advised that the objectives be redrafted and should not have any false claims. Otherwise the members approved of the syllabus.

**Minutes** : All the members of the Board of Studies have approved the title, "Technical Writing Skills" of the already approved open elective course.
