Mrs A. Vijayalakshmi, Assistant Professor(Sr), BoS English, occupied the chair and conducted the proceedings.

# Item No.1: Approval of the syllabus for the course Indian Traditional Knowledge -BE/B.Tech III & IV Semesters -All branches)

Minutes: The syllabus for Indian Traditional Knowledge was thoroughly discussed and deliberated upon in the BoS meeting. It was unanimously resolved that since the course is mandatory and the syllabus has been prescribed by the AICTE no major changes would be brought about in the syllabus. The syllabus was approved by the BoS members after removal of "Introduction to Mayamatam" from the AICTE prescribed syllabus as it was considered to be too difficult for the students. It was also decided that the department requires adequate resources to handle it. The BoS members recommended that the department should outsource or invite people from outside who are experts in the field to handle the course. The Code for the syllabus 20EGM02 was approved by the BoS.

# Item No. 2: Approval of the syllabus for the course Universal Human Values-II: Understanding Harmony - BE/B.Tech III & IV Semesters -All branches)

Minutes: The BoS members resolved to keep intact the syllabus for the compulsory credit course, Universal Human Values-II: Understanding Harmony as it has been provided by AICTE. Professor & Chairperson, OU, drew attention to the conspicuous absence of ancient Indian texts as the Jataka stories or Kathasaritasagara, which are embedded with values. Professor & Chairperson, OU, also recommended to include two texts in the References:

- 1) AMARTYA SEN, The Argumentative Indian.
- 2) SHASHI THAROOR, The Hindu Way of Life.

Dr. V. Parvathi informed that AICTE regularly conducts programs on Universal Human Values and Indian Traditional Knowledge and materials used during the orientation programme can be used for the course. It was also mentioned that any faculty handling the subject should have a minimum exposure to at least one 8-day FDP on the subject. Dr P. Aparna also emphasised on the training and suggested that a workshop could be arranged to guide and motivate people as to how to take the classes. The BoS members also stressed upon that it is to be highlighted that the course is to be taught by faculty from every teaching department. Based upon the suggestions of the BoS, the Course Outcomes was slightly modified. the syllabus was then unanimously approved by the BoS.

# Item No. 3: Changes to be brought about in the unit V of Soft skills Lab Syllabus- V & VI SEM

Minutes: It was informed that the course would now be taught in the V and VI Semester instead of the III and IV semester so that it would help the students at the time of placements. It was unanimously resolved to rename the title of the Soft Skills Lab course as Employability Skills. Dr YL Srinivas suggested to include Hypothesis, and Dr. P. Aparna suggested to include Plagiarism in Unit IV. It was resolved to include elements in the V Unit of the syllabus which will help the students prepare for competitive exams. As such, the following elements were included in Unit V- Verbal Aptitude- Sentence correction, sentence completion, jumbled sentences, vocabulary and Reading Comprehension. After a thorough revision and restructuring of the course Objectives, Course Outcomes, syllabus design, and Proofreading, the syllabus was approved by the BoS.

# Item No. 4: Revising Approval of CIE for English Lab 20EGC02 in R 20 Scheme (BE/BTech I & II Semesters -All branches)

Minutes: The BoS members suggested that the terminology used in the Lab CIE should be contextual as well as appropriate and the tools used to assess the students for the Lab CIE need to be clearly defined. After thorough deliberations and based upon the suggestions of the BoS members it was decided to keep the following five Performance Indicators in the Lab CIE rubrics:

- o Pre Activity Preparation work
- o Activity Performance
- o Post Activity Analysis[Viva, Inference]
- Record Writing
- o Personal and Professional Etiquette

#### Introduction

This course discusses the role of human values in one's family, in society and in nature. In the Induction Program, students would get an initial exposure to human values through Universal Human Values–I. This exposure is to be augmented by this compulsory full semester foundation course.

# **Course Objectives**

- Development of a holistic perspective based on self-exploration about themselves (human being), family, society andnature/existence.
- Understanding (or developing clarity) of the harmony in human being, family, society and nature/existence.
- 3. Strengthening ofself-reflection.
- 4. Development of commitment and courage toact.

#### Course Outcomes

By the end of the course,

- 1. Students are expected to become more aware of themselves, and their surroundings (family, society,nature)
- 2. They would become more responsible in life, and in handling problems with sustainable solutions, while keeping human relationships and human nature inmind.
- 3. They would have better criticalability.
- 4. They would also become sensitive to their commitment towards what they have understood (human values, human relationship and humansociety).
- 5. It is hoped that they would be able to apply what they have learnt to their own self in different day-to-day settings in real life, at least a beginning would be made in this direction.

The course has 28 lectures and 14 practice sessions:

# Unit 1: Course Introduction - Need, Basic Guidelines, Content and Process for Value Education

- Purpose and motivation for the course, recapitulation from Universal HumanValues-I
- Self-Exploration-what is it? Its content and process; 'Natural Acceptance' and Experiential Validation- as the process forself-exploration
- Continuous Happiness and Prosperity- A look at basic HumanAspirations
- Right understanding, Relationship and Physical Facility- the basic requirements for fulfilment of aspirations of every human being with their correctpriority
- Understanding Happiness and Prosperity correctly- A critical appraisal of the currentScenario
- Method to fulfil the above human aspirations: understanding and living in harmony at various levels.

Include practice sessions to discuss natural acceptance in human being as the innate acceptance for living with responsibility (living in relationship, harmony and co-existence) rather than as arbitrariness in choice based on liking-disliking.

# Unit 2: Understanding Harmony in the Human Being - Harmony in Myself

- Understanding human being as a co-existence of the sentient 'l' and the material Body'
- Understanding the needs of Self ('1') and 'Body' happiness and physicalfacility
- Understanding the Body as an instrument of 'I' (I being the doer, seer andenjoyer)
- Understanding the characteristics and activities of 'l' and harmony in'l'
- Understanding the harmony of I with the Body: Sanyam and Health; correct appraisal of Physical needs, meaning of Prosperity indetail
- Programs to ensure Sanyam and Health.

Tutorials (experiments or practical) are important for the course. The difference is that the laboratory is everyday life, and practicals are how you behave and work in real life. Depending on the nature of topics, worksheets, home assignments and/or activities are included.

The practice sessions (tutorials) would also provide support to a student in performing actions commensurate to his/her beliefs. It is intended that this would lead to development of commitment, namely behaving and

working based on basic humanvalues.

# Assessment:

This is a compulsory credit course. The assessment is to provide a fair state of development of the student, so participation in classroom discussions, self- assessment, peer assessment etc. will be used in evaluation. Example:

Assessment by faculty mentor: 10 marks Self-assessment/Assessment by peers: 10 M

Socially relevant project/Group Activities/Assignments: 20 marks

Semester End Examination: 60 marks

The overall pass percentage is 40%. In case the student fails, he/she must repeat the course.


