Note: Canadians and Bermudians are not required to obtain visa stamps to enter the U.S., but must pay the SEVIS Fee. Please keep a copy of your SEVIS fee receipt for entering the U.S.

Before entering the United States, you must apply for an F-1 visa at the U.S. Embassy or Consulate in your home country. Please carefully read and follow the instructions below.

Step 1: Paying SEVIS Fee (I-901)

New students carrying an initial I-20 cannot enter the US **sooner than 30 days before the program start date** listed on the I-20, even if you have a valid F-1 visa. The earliest date on which you can enter the US is printed on the I-20 – see EARLIEST ADMISSION DATE under Program of Study.
