1. PURPOSE

This Memorandum of Understanding (MoU) establishes a collaborative framework between Chaitanya Bharathi Institute of Technology (CBIT), hereinafter referred to as "the First Party" or "CBIT", and Gradvision Edtech Private Limited, hereinafter referred to as "the Second Party" or "GEPL". 3. RESPONSIBILITIES OF THE FIRST PARTY

- 1 Access to Students: The First Party will provide access to its students to participate in the Career Lab and Internship Program.
- 2 Infrastructure Support: The First Party will provide the necessary infrastructure for program implementation (e.g., classrooms for workshops, computer labs for platform access)
- 3 Promotion: The First Party will actively promote the program within its branches and ensure student participation across all eligible grades.
- 4 Student Engagement: The First Party will ensure that students engage with the program, including completing assessments, attending workshops, and participating in internships.
- 5 Fee Collection: Students shall pay the Annual Program Fees directly to the GV Edtech

5. Fee Payment Communication:

The First Party shall inform students that the Annual Program Fee is to be paid directly to GEPL (Gradvision Edtech Private Limited). The First Party shall not be responsible for fee collection. Introduction of the program of the program of the program.

4. RESPONSIBILITIES OF THE SECOND PARTY

- Program Implementation: The Second Party will provide the online platform, career assessments, online and offline workshops, and industry partnerships to facilitate the program. The features of the online platform are highlighted in Annexure I.
- 2 Training & Support: The Second Party will provide training for The First Party staff and counsellors and also students for implementing the Career Lab and Internship Program.
- 3 Internship Partnerships: The Second Party will establish relationships with Industries and companies for providing virtual internship opportunities to The First Party's students. The second part will also enable First party to sign MoUs with Industries and companies wherever possible.
- 4 Monitoring & Reporting: The Second Party will provide periodic updates and reportson program progress and outcomes to The First Party.

5. RESPONSIBILITIES OF THE SECOND PARTY (GEPL)

1. Program Implementation:

The Second Party shall provide the required infrastructure for program execution, including access to its online platform, career assessments, online and offline workshops, and relevant industry partnerships based on availability of the facility. Detailed features of the online platform are outlined in **Annexure I**.

2. Training & Support:

The Second Party shall offer necessary training and support to the First Party's staff, counselors, and students to ensure effective implementation and utilization of the Career Lab and Internship Program.

3. Industry Partnerships & MoUs:

The Second Party shall establish collaborations with industries and companies to offer meaningful virtual internship opportunities to the students of the First Party.

Wherever feasible, the Second Party shall also facilitate the signing of MoUs between the First Party and industry partners.

- 4. Monitoring & Reporting:
- The Second Party shall provide regular updates, reports, and analytics on program implementation, student participation, and outcomes to the First Party.
- 6. Point of Contact (SPOCs):

Both parties shall nominate **two Single Points of Contact (SPOCs)** from their respective sides to ensure smooth coordination, communication, and execution of the program.

6.TERMS OF AGREEMENT

- 1 Duration: This MOU is valid for an initial period of 3 years, with an option for renewal based on mutual agreement.
- **2 Fees and Payment:** Each interested student shall pay an "Annual Fee" directly to Grad Vision EdTech Pvt. Ltd. (The Second Party) for the services provided, which include the Career Lab, Internship Program, and Skill Development Workshops. The First Party shall facilitate communication and coordination with students but shall not be responsible for collecting the fee. Grad Vision EdTech will issue invoices directly to the students. The aforementioned "Annual Fee" shall be as per the fee structure provided in the table below and may be revised in subsequent years based on mutual understanding.

7.CONFIDENTIALITY

- 1 Each Party shall undertake to observe the secrecy of confidential information received from or supplied to the other Party during the period of implementation of this MoU or other agreements made pursuant to this MoU.
- 2 For purposes of this MoU, "confidential information" means any information whether prior to or hereinafter disclosed by the Second Party (the disclosing Party) to the First

Party (the Receiving Party) of this MoU involving personal details of Assessee, technical, business, marketing policy, know-how, planning, project management and other information, data and/or solutions in any form, including but not limited to any information which is designated in writing to be confidential or by its nature intended to be for the knowledge of the Receiving Party or if orally given, is given in the circumstances of confidence.

- 3 All the databases generated by The Second Party will be confidential and will not be shared or used in any manner by The First Party for commercial purposes.
- 4 Both Parties agree that the provisions of this Clause shall continue to be binding between the Parties notwithstanding the termination of this MoU.

8.NTELLECTUAL PROPERTY

Any intellectual property developed by either party as a result of this partnership (such as AI algorithms, assessment tools, course materials) shall remain the property of the respective party. Both parties agree to respect the intellectual property rights of each other. In case of any disputes, it will be mutually discussed and solved.

9.SETTLEMENT OF DISPUTES

- 1 Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this MoU shall first be settled amicably through mutual consultation and/or negotiations between the Parties.
- 2 In the event of non-resolution, reference shall be made to a mediator jointly appointed by the Parties who shall mediate the dispute or difference in question.
